<p>CONSENT</p>	<p>I/We, the parents/guardians of the above-named candidate for a position on a team in the Freehold Township Little League ("FTLL"), hereby give my/our approval to participate in any and all Little League activities, including transportation to and from the activities. I/We know that participation in baseball may result in serious injuries and protective equipment does not prevent all injuries to players, and do hereby waive, release, absolve, indemnify, and agree to hold harmless the FTLL, Little League Baseball, Inc., the organizers, sponsors, supervisors, participants, and persons transporting my/our child to and from activities from any claim arising out of any injury to my/our child whether the result of negligence or for any other cause.</p>
<p>INSURANCE / MEDICAL AUTHORIZATION</p>	<p>The Little League insurance will supplement my own insurance program, where necessary. All claims must be submitted immediately to the President or Safety Director of the League. I/We agree to complete and sign the Medical Affidavit prior to above-named candidate's participation in FTLL activities.</p>
<p>PROOF OF AGE / RESIDENCY</p>	<p>I/We agree to provide proof of legal residence (as defined by Little League Baseball, Inc.) and age. I/We understand that our child (candidate) must be eligible under the residence and age regulations of Little League Baseball, Inc., to participate in the FTLL, and that if any controversy arises regarding residence and/or age, the decision of the Charter Committee in Williamsport shall be final and binding. I/We further understand that if any participant on a Little League team does not qualify for participation based on residence (as defined by Little League Baseball, Inc.) and/or age, such participant and/or team which he/she participates be found ineligible, and forfeit(s), and/or suspension of Tournament privileges may be decreed by action of the Charter Committee or Tournament Committee.</p> <p>I/We will furnish a certified birth certificate and proof of address (POA) of the above-named candidate to the FTLL officials at the candidate's initial registration, when requested by FTLL officials, or if the candidate's residency changes. The POA must conform to Little League requirements. The candidate cannot be considered for initial registration without these documents.</p>
<p>ASSISTANCE / VOLUNTEERS Managers / Coaches, etc. - submit official Volunteer Form</p>	<p>I/We understand that a condition of participation is my/our agreement to volunteer a reasonable amount of time to the FTLL program. I/We agree to fulfill the specific volunteer activities required of FTLL members as determined by FTLL Officials and enforced by the Team Manager or designate. Please complete the Volunteer form if you are willing to provide additional assistance to the League. Little League is run by volunteers, and if I/we do not assist in the program, then I understand that the FTLL is not required to accept my child if the size of the league must be adjusted to match the level of volunteer help. I/We understand that a fee may be imposed for my unwillingness to volunteer.</p>
<p>OUTSIDE TEAM PARTICIPATION</p>	<p>Participation on teams outside of the FTLL and Middle/High School is permitted. Code of Conduct

The participants, parents or legal guardians of minor participants, coaches and officials of every sports organization shall be required to follow the Code of Conduct, set forth as follows:

I hereby pledge to be responsible for my words and actions while attending, coaching or participating in a Township sports event and shall confirm my behavior to the following code of conduct:

1. I will not engage in unsportsmanlike conduct with any coach, parent, player, participant, official or any other attendee.
2. I will not encourage my child, or any other person, to engage in unsportsmanlike conduct with any coach, parent, player, participant, official or any other attendee.
3. I will not engage in any behavior which would endanger the health, safety or well-being of any coach, parent, player, participant, official or any other attendee.
4. I will not encourage my child, or any other person, to engage in any behavior which would endanger the health, safety or well-being of any coach, parent, player, participant, official or any other attendee.
5. I will not use drugs or alcohol while at a youth sports event and will not attend, coach, officiate or participate in a youth sports event while under the influence of drugs or alcohol.
6. I will not permit my child, or encourage any other person, to use drugs or alcohol while at a youth sports event and will not permit my child, or encourage any other person, to attend, coach, officiate or participate in a youth sports event while under the influence of drugs or alcohol.
7. I will not engage in the use of profanity.
8. I will not encourage my child, or any other person, to engage in the use of profanity.
9. I will treat any coach, parent, player, participant, official or any other attendee with respect regardless of race, creed, color, national origin, sex, sexual orientation or ability.
10. I will encourage my child to treat any coach, parent, player, participant, official or any other attendee with respect regardless of race, creed, color, national origin, sex, sexual orientation or ability.
11. I will not engage in verbal or physical threats aimed at any coach, parent, player, participant, official or any other attendee.
12. I will not encourage my child, or any other person, to engage in verbal or physical threats or abuse aimed at any coach, parent, player, participant, official or any other attendee.
13. I will not initiate a fight or scuffle with any coach, parent, player, participant, official of any other attendee.
14. I will not encourage my child, or any other person, to initiate a fight or scuffle with a any coach, parent, player, participant, official of any other attendee.
15. I will abide by any decision rendered by the Code of Conduct Committee or the Township Parks and Recreation Commission.
16. I will be responsible for the behavior of all those attending the Township youth sports event on my child's behalf.
